

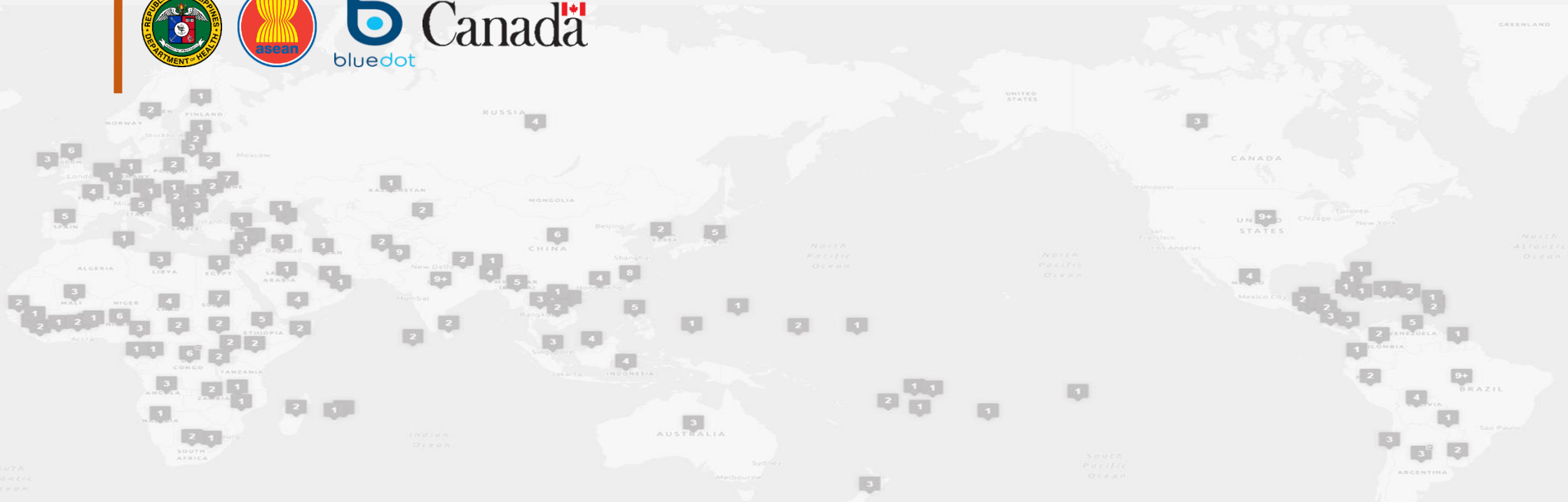

COVID-19: Highlights and Situation Overview

- Worldwide, there have been over 73.6 million cases and more than 1.63 million deaths attributed to COVID-19.
- 1,295 new cases were reported. The country reported 2,234 cases on December 10, representing a record-high number of cases reported within a 24-hour period since the beginning of the outbreak. The seven-day rolling average number of daily new cases continues to rise, reaching 1,616 as of December 15. Several new clusters of cases have recently been identified, including three at construction sites (Jalan Bukit Construction Site in Hulu Selangor, Condong Construction Site, and Jalan Stadium Construction Site in Kuala Lumpur). Authorities announced that restrictions currently in place are to remain until December 31. Zones under Conditional Movement Control Order (CMCO) or Enhanced Movement Control Order (EMCO) may have existing curfews in place, depending on local governments. The CMCO will be in effect until December 20 in the city of Kuala Lumpur and to varying geographic extents in the states of Sabah, Selangor, Penang, Johor, Negeri Sembilan, Kelantan, Perak, and Sabah. In regions where the CMCO is in effect, educational institutions, public parks, and recreational centers are closed with the only exception being childcare centers that may apply for special permission to reopen. Mosques and other places of worship may operate on a limited basis. Sports, recreational, social, and cultural activities may operate at a limited capacity. Entertainment centers and nightclubs are not allowed to operate. The ban on foreign tourists entering the country has also been extended until the end of the year. International borders remain closed and entry into Malaysia is prohibited, except for Malaysian nationals and non-citizens holding certain categories of resident and employment passes or granted special entry. The 14-day quarantine at a government facility remains mandatory as previously regulated for all arrivals. Despite the outbreak in the country, most economic and social activity has resumed in places without CMCO and EMCO, although nightclubs remain closed.

Vaccine Update

- COVID-19 vaccine candidates are being studied in Phase 3 or Phase 2/3 trials. Three new vaccine candidates have entered Phase 3 or Phase 2/3 trials since our previous report, which are those developed by AnGes/Osaka University/Takara Bio, Bharat BioTech/Indian Council of Medical Research/National Institute of Virology, CureVac, and the Chinese Academy of Medical Sciences respectively.
- As of December 16, Pfizer/BioNTech have been approved for emergency use by the United Kingdom, Bahrain, Canada, United States, Mexico, and Singapore. The next vaccine candidate to be evaluated by the U.S. Food and Drug Administration (FDA) is Moderna's vaccine candidate.
- Both the Centers for Disease Control and Prevention in the U.S. and the World Health Organization have advised on a plan for vaccine allocation when supply is limited. In the initial rollout, most vaccines are reserved for healthcare workers and older adults at high risk of acquiring and complications of COVID-19.

- According to Health Officials, China plans to start opening its vaccination programme to members of the public in southwestern Sichuan province early next year. At least one million people have already received a jab in China after vaccine candidates were approved for "emergency use", but so far, they have been limited to priority groups such as state employees and international students. China has five coronavirus vaccines in the final stages of development -- but none has received official approval from authorities and the results of late-stage trials have yet to be published. A provincial health official told local media that vaccines will be provided to the general public in Sichuan after the Lunar New year holidays in February.
- The Indonesian Food and Drug Monitoring Agency (BPOM) has announced that it will extend the monitoring stage of a phase three clinical trial for the Chinese-developed vaccine Sinovac for another three months to determine the vaccine's efficacy and side effects. BPOM had ordered researchers to take other blood samples from the volunteers six months after the first injections of the Sinovac vaccine to ensure that they would still have antibodies against the coronavirus in the long run.
- Drugmaker Pfizer said on Friday (December 18) it had applied for approval in Japan of its COVID-19 vaccine, which is already being administered in the United Kingdom and the United States. The Japanese government has a supply deal with Pfizer for 120 million vaccine doses of the vaccine made by Pfizer and German partner BioNTech. Pfizer said in a statement it had made the application to Japan's Health Ministry, along with providing information on tests it has carried out up to now.
- A Vietnamese pharmaceutical company Nanogen began testing a coronavirus vaccine (Nanocovax) on volunteers in Hanoi on Thursday (December 17). Three volunteers received the jab on Thursday and will be monitored for 72 hours at the Vietnam Military Medical University. The health ministry said that 60 participants will receive the vaccine in the first phase of the trial.

Travel Advisories (new update/s)

- Thailand: Thailand on Thursday (December 17) eased travel restrictions for citizens from 56 countries. However, travellers will be required to undergo a mandatory two-week hotel quarantine. Tourists from countries including Australia, France and the United States can travel without visas, but would need a certificate to show they were free of COVID-19 72 hours before travel and a place at a quarantine hotel. While in quarantine, arrivals would undergo three COVID-19 tests, up from two required previously. Meanwhile, travelers from other countries not included in Thursday's announcement could still be eligible for a 90-day special tourist visa and a certificate of entry.

Cases and Deaths as of 18 December 2020

- As of December 18 (2PM, GMT+8), worldwide, there were **75,314,591** confirmed cases, including **1,668,296** deaths. Globally, Case Fatality Rate (CFR) is **2.22**.
- In **China**, there were **95,480** confirmed cases with **4,765** deaths, including deaths in Hong Kong (124) and Taiwan (7). Confirmed cases in China include confirmed cases in Hong Kong (7,900), Macau (46), and Taiwan (757).
- **1,364,790 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **31,176 deaths**.

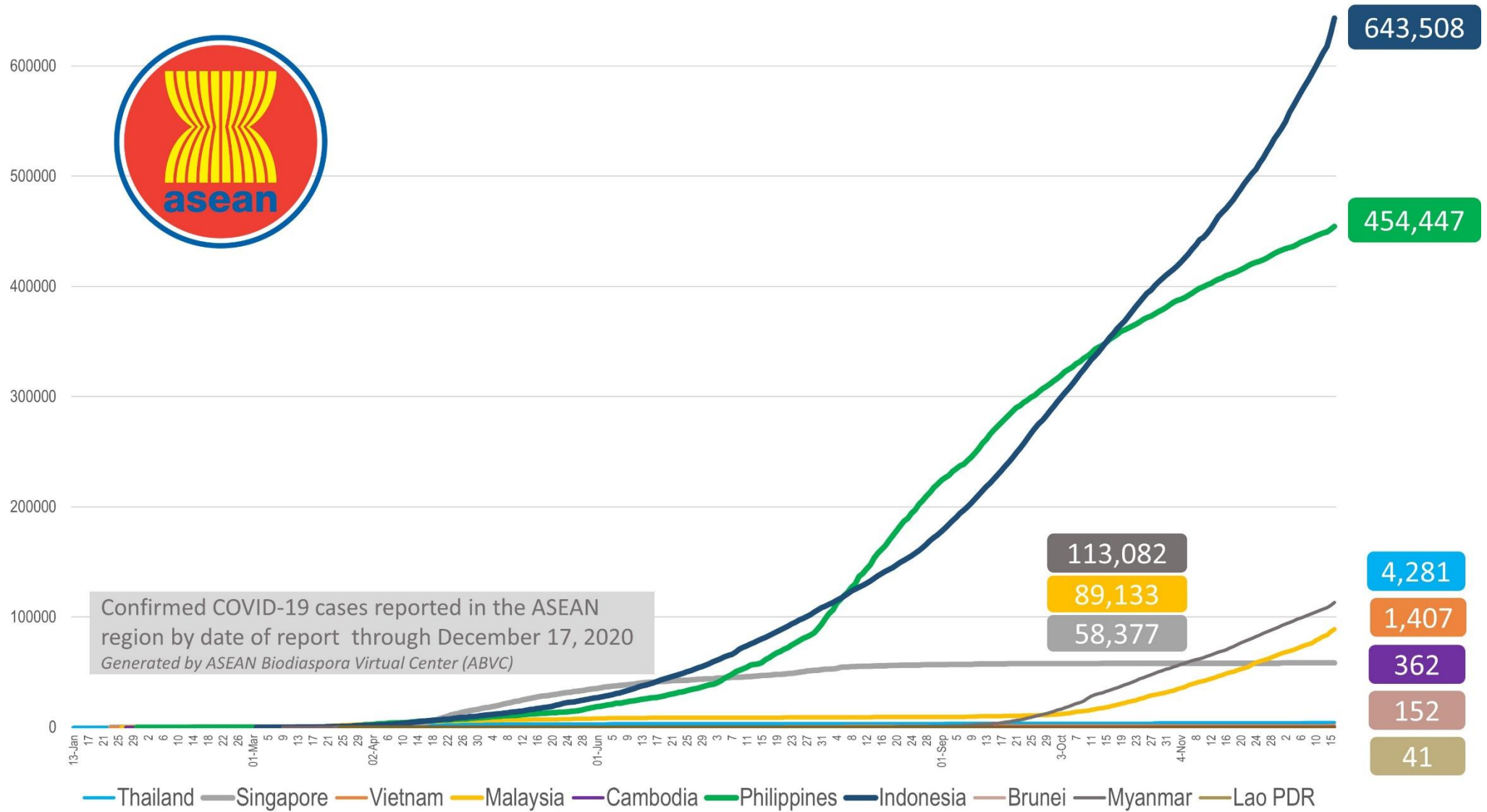
