

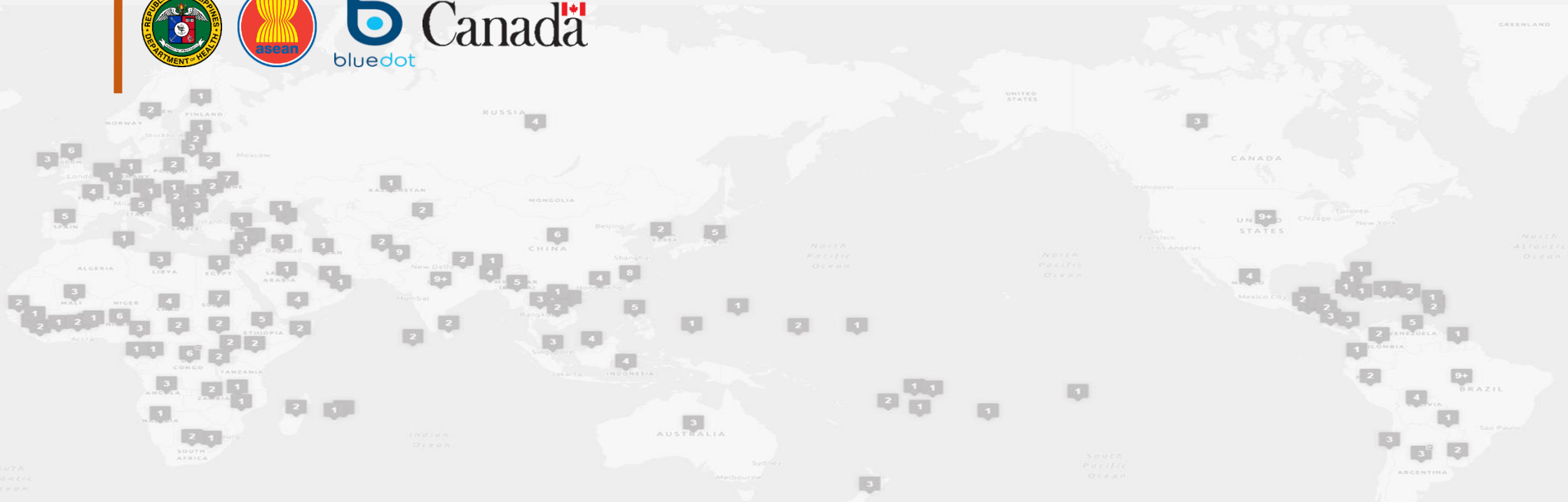

COVID-19: Highlights and Situation Overview

- Worldwide, there have been over 62.9 million cases and more than 1.46 million deaths attributed to COVID-19.
- All new cases in Singapore were imported. Since early October, case activity has largely been limited to single digits, with the vast majority of incidence attributed to foreign travel. The country had experienced almost 14 consecutive days without registering local transmission of the SARS-CoV-2, until one case was reported on November 26. The incident involved a 32-year-old service engineer, previously unlinked to any cases. Prior to testing positive, the individual had dinner with 12 family members at a restaurant in Tampines Mall, which has since prompted the entire centre to close temporarily, pending investigation. All close contacts of the case have been isolated and placed under quarantine. Earlier this week, the Ministry of Health formally announced the closure of a COVID-19 cluster in a foreign worker dormitory, following two incubation periods with no evidence of disease activity. With this announcement, no active clusters exist in Singapore for the first time since February 3, 2020. Following a recent surge of cases in Hong Kong -- including 13 of untraceable origin -- the planned bubble between Singapore and Hong Kong (which entailed quarantine-free travel slated to begin on November 22) has been postponed for at least two weeks. As part of the program, both countries had agreed to temporarily suspend the program if the number of local, unknown cases exceeded five on a seven-day rolling average (Hong Kong is currently recording ~4). An uptick of recently imported cases in Singapore has also prompted the government to tighten travel restrictions on select countries. As of November 28, individuals with a travel history to Malaysia, Japan, Finland, or Turkey over the past two weeks will be required to serve a 14-day quarantine at designated facilities; this was shifted from 7 to 14-day quarantine at a home residence. To boost domestic tourism in the country, the government will be granting each citizen aged 18 and over with S\$100 worth of SingapoRediscovered vouchers that can be redeemed for staycations, attraction tickets, and tours as of December 1.
- According to Bogor Deputy Regent, COVID-19 hospitals in Bogor Regency, West Java, have shown a rapid increase in patient intake. According to the government official, several hospitals have reached full capacity and some are 75% occupied, exceeding the World Health Organization's (WHO) suggestion of 60% capacity. The occupancy rate increased in the wake of a series of mass gatherings centered around the return of Islam Defenders Front (FPI) leader Rizieq Shihab from self-exile in Saudi Arabia, as well as a long weekend in late October. These factors have also contributed to the rising number of daily COVID-19 cases since the sixth phase of large-scale social restrictions (PSBB). He expressed his concerns that the regency was unable to control the spread of the virus. Bogor regency extended PSBB measures for another 28 days. Indonesia Health Ministry reported 6,267 new confirmed COVID-19 cases on Sunday (November 29), bringing the total number of cases nationwide to 534,266.
- Myanmar government has further extended the country's COVID-19 preventive measures until December 15 as the number of cases continues to increase in the country.

Vaccine Update

- State-owned pharmaceutical company PT Bio Farma is still waiting for results from the phase three clinical trial of a COVID-19 vaccine produced by Sinovac Biotech for the vaccine to be authorized for public use. Padjadjaran University's School of Medicine is currently conducting the phase three clinical trial in Bandung, West Java. However, BPOM head said that emergency use authorization (EUA) could be granted before the clinical trials are completed. She went on to explain that her agency only needed to conduct a fit-and-proper trial for the vaccine as long as health authorities and vaccine research teams in other participating countries had obtained the data for the clinical trials. Up to 1,620 volunteers in Bandung are participating in the clinical trial of the Sinovac COVID-19 vaccine that is set to end in the first or second week of January 2021. The report will provide additional data on the safety, quality and efficacy of the Sinovac vaccine, in addition to the clinical trials conducted in Brazil. The BPOM will then consider the report to issue the EUA for the Sinovac vaccine.
- Thailand on Friday (November 27) signed a \$200 million deal to procure 26 million doses of a trial coronavirus vaccine developed by pharmaceutical firm AstraZeneca in collaboration with Oxford University. It is expected to be delivered in mid-2021. The doses would cover 13 million people in a population of about 69 million. Government spokesperson said that officials are still considering how to prioritize vaccine recipients. Meanwhile, in the Philippines, more than 30 companies on Friday (November 27) signed an agreement to purchase at least 2.6 million vaccine doses from AstraZeneca in the country's first such deal to secure coronavirus vaccines. They plan to donate a large part of the doses to the government for its planned vaccination program and use the rest to inoculate their employees. Business leader Jose Concepcion III said the vaccine is expected to be delivered in the second quarter of next year and would cover about 1 million people, but did not disclose other details. The Philippine government says it's targeting about 60 million Filipinos to be vaccinated against the coronavirus over about two years starting next year.
- According to Malaysia's Prime Minister on Saturday (November 28), a total of 9.6 million people or 30% of Malaysia's population are expected to be vaccinated against COVID-19 next year. He noted that the government has signed two agreements for the procurement of COVID-19 vaccines. In addition to the agreement with Pfizer that was announced on Friday, the prime minister said Malaysia has inked an agreement with the COVAX facility to get enough vaccines for 10 per cent of the country's population. Malaysia will receive the vaccine supply in stages from the first quarter of 2021, he said during his speech at the annual general assembly of Parti Pribumi Bersatu Malaysia (Bersatu) which was held virtually this year in light of COVID-19.

Travel Advisories (new update/s)

- Philippines: According to the Office of the President today (November 27), Filipino citizens' foreign spouses and children, along with returning Filipinos will be allowed to enter the Philippines starting December 7. Also permitted is the entry of former Filipino citizens, including their spouses and children, regardless of age, who are travelling with them. They are allowed to enter the country provided they secure a booking at a quarantine facility and have a swab test schedule at Philippine airports

Cases and Deaths as of 30 November 2020

- As of November 30 (2PM, GMT+8), worldwide, there were **63,101,525** confirmed cases, including **1,466,028** deaths. Globally, Case Fatality Rate (CFR) is **2.32**.
- In **China**, there were **93,448** confirmed cases with **4,750** deaths, including deaths in Hong Kong (109) and Taiwan (7). Confirmed cases in China include confirmed cases in Hong Kong (6,239), Macau (46), and Taiwan (651).
- 1,182,138 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **27,590 deaths**.

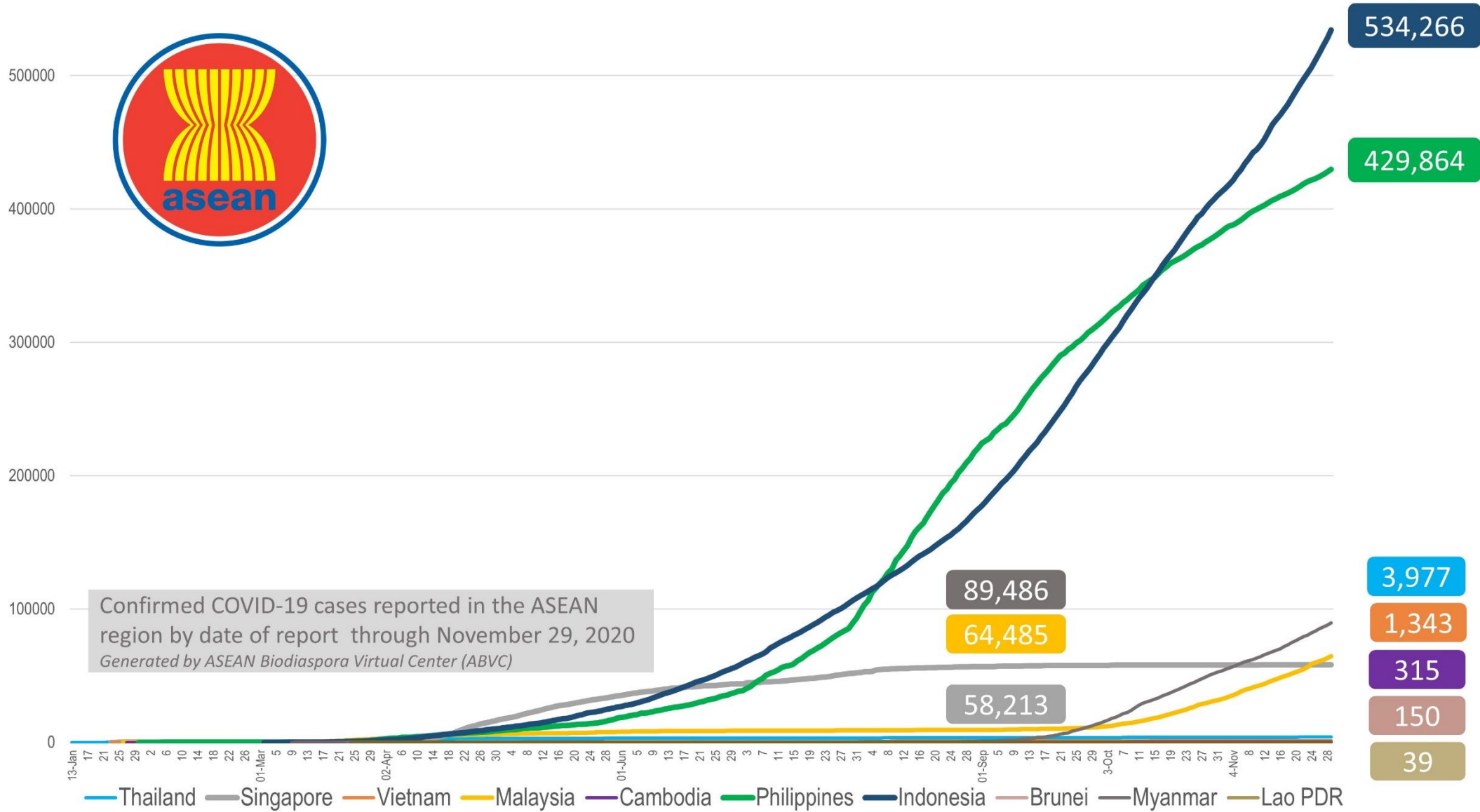
