REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA

NUMBER 67/M-DAG/PER/11/2013 CONCERNING OBLIGATION TO AFFIX BAHASA INDONESIA LABEL ON GOODS

BY THE GRACE OF THE ALMIGHTY GOD THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering : a. that in order to ensure Consumer rights to accurate, clear, and truthful information on the condition of and guarantee for the goods to be worn, used, or utilized by Consumers, it is necessary to regulate the obligation to affix Bahasa Indonesia label on goods as regulated in Regulation of the Minister of Trade Number 62/M-DAG/PER/12/2009 concerning Obligation to Affix Label on Goods as amended by Regulation of the Minister of Trade Number 22/M-DAG/PER/5/2010;

b. that under the foregoing considerations in point a, it is necessary to establish a Regulation of the Minister of Trade on Obligation to Affix Bahasa Indonesia Label on Goods;

HAS DECIDED:

To stipulate : REGULATION OF THE MINISTER OF TRADE CONCERNING OBLIGATION TO AFFIX BAHASA INDONESIA LABEL ON GOODS.

Article 1

In this Minister Regulation, the following terms mean:

- 1. Label is all information on goods in the form of image, text, combination of the two, or other forms that contain information on the goods and Businessmen information as well as other information based on the provisions of the prevailing laws and regulations.
- 2. Good is every tangible and intangible object, whether movable or immovable, exhaustible or inexhaustible, that can be traded, worn, used, or utilized by Consumer.
- 3. Import is the activity of entering a good into a Customs Area.
- 4. Customs Area is a territory of the Republic of Indonesia comprising land, water, and the air space above them, as well as certain areas in the Exclusive Economic Zone and Continental Shelf contained within where the provisions of laws and regulations on customs apply.
- 5. Businessman is every individual or business entity, whether in the form of a legal entity or non-legal entity, established and residing or conducting activities in the legal territory of the Republic of Indonesia.

- 6. Consumer is every user of goods and/or services available in the society, whether in the interest of the person, family, others, or other living entities and not for trade.
- 7. Market is the point of meet between sellers and buyers to conduct transaction in which a sales and purchase process is established.
- 8. Packaging is a packaged used to pack and/or wrap Goods, whether directly in contact with the Goods or not.
- 9. Bulk Goods is liquid or solid Goods to be traded by measuring the volume or weight of the Goods before the Consumer.
- 10. Raw Material is Goods and/or materials to be processed into a Goods product with higher utilization value.
- 11. Supporting Material is Goods and/or materials other than Raw Material used in processing or consolidation activities that function to support production process.
- 12. Delivered Goods is Import Goods delivered by certain deliverers in other countries to certain receivers in the country.
- 13. Re-Import Goods is Goods delivered to other countries that will be reentered into the Customs Area.
- 14. Temporary Import Goods is Import Goods of which entry uses the Temporary Import mechanism.
- 15. Sample Goods is all Goods imported specifically as samples of product manufacture to be exported or to be marketed domestically.
- 16. Personal Effect is household Goods owned by a person who originally domiciles in other countries and moved into the country.
- 17. Bahasa Indonesia Label Affixing Certificate, hereinafter abbreviated as SKPLBI, is a certificate explaining that the sample of Label submitted by a Businessman has met the requirements.
- 18. Bahasa Indonesia Label Affixing Obligation Exemption Certificate, hereinafter abbreviated as SPKPLBI is a certificate explaining that the relevant Good is exempted from the obligation to affix label.
- 19. Trading Service Unit, hereinafter is abbreviated as UPP is a unit that conducts licensing service in the trading sector.

- 20. Minister is the Minister who conducts government affairs in the field of trade.
- 21. UPP Coordinator and Implementer is the Officer appointed by the Secretary General of the Ministry of Trade to coordinate and implement the conduct of licensing service in the UPP.

Article 2

- (1) Businessmen who produce or import Goods to be traded in the domestic Market as referred to in this Appendix to the Minister Regulation must affix Label in Bahasa Indonesia.
- (2) The Appendix to the Minister Regulation as referred to in paragraph (1) consists of:
 - a. Appendix I, containing the list of electronic, household, telecommunication, and informatics Goods;
 - b. Appendix II, containing the list of construction material Goods;
 - c. Appendix III, containing the list of motor vehicles support Goods (spare parts and others);
 - d. Appendix IV, containing the list of other Goods; and
 - e. Appendix V, containing the list additional Goods and expansion of Goods.
- (3) Label Affixing referred to in paragraph (1) must at least use clear and simple Bahasa Indonesia.
- (4) The use of other Languages than Bahasa Indonesia, Arabic numbers, Latin alphabets, is allowed in the event that there is no equivalent.

Article 3

- (1) Goods imported by Businessmen as referred to in Article 2, upon entering the Customs Area must have been affixed with Bahasa Indonesia Label.
- (2) Businessmen importing Goods referred to in paragraph (1) is responsible for the Good imported.

Article 4

- (1) Businessmen who produce or import Goods to be traded in the domestic Market as referred to in this Appendix to the Minister Regulation must affix Label in Bahasa Indonesia.
- (2) The Appendix to the Minister Regulation as referred to in paragraph (1) consists of:
 - a. Appendix I, containing the list of electronic, household, telecommunication, and informatics Goods;
 - b. Appendix II, containing the list of construction material Goods;
 - c. Appendix III, containing the list of motor vehicles support Goods (spare parts and others);
 - d. Appendix IV, containing the list of other Goods; and

e. Appendix V, containing the list additional Goods and expansion of Goods.

Article 5

- (1) The Label referred to in Article 2 paragraph (1) contains information or explanation on the Goods and the identity of the Businessman as stipulated in Appendix I, Appendix II, Appendix III, Appendix IV, and Appendix V of this Minister Regulation.
- (2) Information or explanation on the Goods Label in relation to safety, security, and health of the Consumers and the environment, must contain:
 - a. method of usage; and
 - b. hazard symbol and/or clear warning sign.
- (3) Businessmen Identity referred to in paragraph (1) must at least contain:
 - a. name and address of the manufacturer for Goods produced domestically; or
 - b. name and address of the importer for Imported Goods.
- (4) Manufacturer's and importer's address referred to in paragraph (3) must at least contain the company name and the city of domicile of the relevant company.

Article 6

In addition to the information or explanation referred to in Article 5 paragraph (1), Businessmen must include information or explanation that must be stipulated pursuant to the prevailing laws and regulations.

Article 7

Businessmen are prohibited from including a Label that:

- a. is incomplete; or
- b. contains inaccurate and/or misleading information for the Consumer.

Article 8

- (1) Businessmen producing or importing the Goods referred to in Article 2 paragraph (1) must submit an SKPLBI application to the Director General of Standardization and Consumer Protection, in this case the Director of Consumer Empowerment.
- (2) The SKPLBI application submission referred to in paragraph (1) must be completed with the following requirements:
 - a. domestically manufactured goods
 - 1) application letter signed by the head of the company;

- 2) list of goods in hardcopy and softcopy;
- samples of image and Bahasa Indonesia Label affixed to the Goods and/or Packaging in accordance with the list of goods proposed;
- 4) copy of the Industry Business License (IUI), Industry Registration Certificate (TDI) or Authorized Agent Acknowledgment Letter from the authorized technical institution;
- 5) copy of the Taxpayer Registration Number (NPWP) of the company;
- 6) duly stamped power of attorney from the head of the company; if the arrangement is assigned to a third party;
- 7) copy of the identification of the head of the company; and
- 8) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
- b. Imported goods
 - 1) application letter signed by the head of the company;
 - 2) list of Goods imported with HS numbers in hardcopy and softcopy;
 - samples of image and Bahasa Indonesia Label affixed to the Good and/or Packaging in accordance with the list of goods proposed;
 - 4) copy of the Importer's Identification Number (API);
 - 5) copy of the Taxpayer Registration Number (NPWP) of the company;
 - 6) duly stamped statement letter stipulating that the imported Goods have been affixed with a Bahasa Indonesia label upon entering the Customs Area;
 - 7) duly stamped power of attorney from the head of the company; if the arrangement is assigned to a third party;
 - 8) copy of the identification of the head of the company; and
 - 9) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
- (3) The submission of the SKPLBI application referred to in paragraph (1) may be done by:
 - a. Electronic submission through inatrade, upon obtaining the right to access inatrade;
 - b. Directly submitting or through a delivery service to the Director of Consumer Empowerment, Directorate General of Standardization and Consumer Protection, Ministry of Trade of the Republic of Indonesia, through the Trading Service Unit (UPP) of the Ministry of Trade of the Republic of Indonesia, Jalan M.I. Ridwan Rais Nomor 5, Jakarta Pusat 10110.
- (4) Submission of application referred to in paragraph (2) is done by presenting original documents, if necessary.
- (5) The Director of Consumer Empowerment issues:
 - a. SKPLBI based on the category of good at the latest within 5 (five) working days as of the receipt of the complete and satisfactory application; or

- b. SKPLBI issuance rejection within 5 (five) in the event that the application is incomplete and/or unsatisfactory.
- (6) The application format to obtain the SKPLBI, SKPLBI and SKPLBI issuance rejection is as stipulated in Appendix VI, Appendix VII, and Appendix VIII of this Minister Regulation.

Article 9

Businessmen may obtain the right to access inatrade as referred to in Article 8 paragraph (3) point a by referring to the Regulation of the Minister of Trade prescribing the requirements to obtain the right to access inatrade.

Article 10

The SKPLBI is a document explaining that:

- a. a Label for Goods manufactured domestically has met the provisions provided in this Minister Regulation; or
- b. a Label for Imported Goods has met the provisions provided in this Minister Regulation and is a supporting customs document in Import customs completion.

Article 11

- (1) The SKPLBI is valid as long as the Businessman is manufacturing or importing the Goods stipulated in the SKPLBI.
- (2) In the event that the Businessman referred to in paragraph (1) manufactures or imports Goods other than those stipulated in the SKPLBI, the Businessman must submit a new SKPLBI pursuant to the provisions of Article 8.

Article 12

- (1) The SKPLBI as supporting customs document as referred to in Article 10 point b must be forwarded online to the Indonesia National Single Window (INSW) portal.
- (2) In the event that the Import of Goods is conducted through a port that has not been connected to the Indonesia National Single Window (INSW), the SKPLBI is copied manually to the Directorate General of Customs and Excise, the Ministry of Finance.

Article 13

(1) In the event that the Businessman when importing the Goods does not complete the SKPLBI documents, the imported Good must be reexported pursuant to the prevailing laws and regulations. (2) The re-export cost referred to in paragraph (1) is borne by the importer.

Article 14

- (1) The requirements of Bahasa Indonesia Label affixing are not applicable to the Goods as stipulated in Appendix I, Appendix II, Appendix III, Appendix IV, and Appendix V of this Minister Regulation if the Good is in the form of:
 - a. Bulk Goods sold and packaged directly before the Consumer; or
 - b. Goods imported as:
 - 1) Raw Material and/or Supporting Material used in the manufacturing process;
 - 2) Temporary Import Goods;
 - 3) Re-Import Goods;
 - 4) Goods for research and scientific development;
 - 5) Grant, gift, or gift for general prayer, charity, social, cultural, educational needs or for natural disaster mitigation needs;
 - 6) Sample Goods that are not to be traded;
 - 7) Delivery Goods;
 - 8) Passenger, transportation facility crew, and border crossing Goods;
 - 9) Personal Effects;
 - 10)Goods of the representative of other countries and its officials filling their posts in Indonesia;
 - 11)Goods used for government institutions/other state offices imported directly by the institution/office; and/or
 - a. Goods manufactured domestically as Raw Material and/or Supporting Material used in the manufacturing process.
- (2) In the event that manufacturers, motor vehicle authorized agents, general importers or motor vehicle manufacturer's suppliers' import Goods referred to in paragraph (1) point b number 1 to 6 must obtain an SPKPLBI.
- (3) In the event that a manufacturer produces the Goods referred to in paragraph (1) point c must obtain an SPKPLBI.

Article 15

- (1) Manufacturers, motor vehicle authorized agents, general importers or motor vehicle manufacturer's suppliers as referred to in Article 14 paragraph (2) submit an SPKPLBI application to the Director for Consumer Empowerment attn. UPP Coordinator and Implementer.
- (2) The submission of the SPKPLBI application as referred to in paragraph (1) must be completed with the following requirements:
 - a. for Goods manufactured domestically:
 - 1) Manufacturer
 - a) application letter signed by the head of the company;

- b) list of Goods along with a description of designation and amount of Goods in hardcopy and softcopy;
- c) copy of Industry Business License (IUI) or Industry Registration Certificate (TDI);
- d) statement letter stating that the Goods are not to be traded to end Consumers;
- e) copy of the identification of the head of the company; and
- f) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
- 2) Supplier company
 - a) application letter signed by the head of the company;
 - b) list of Goods along with a description of designation and amount of Goods in hardcopy and softcopy;
 - c) copy of Trade Business License (SIUP);
 - d) copy of the company's Taxpayer Registration Number (NPWP)
 - e) duly stamped power of attorney from the head of the company, if the arrangement is assigned to a third party;
 - f) copy of appointment letter from the manufacturer or cooperation agreement between the manufacturer and the supplier company;
 - g) statement letter stating that the Goods are not to be copy of the identification of the head of the company; and
 - h) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
- b. for Import Goods:
 - 1) Manufacturer Importer
 - a) application letter signed by the head of the company;
 - b) list of Goods along with the HS number and designation and amount of Goods;
 - c) copy of Industry Business License (IUI);
 - d) copy of the company's Taxpayer Registration Number (NPWP);
 - e) copy of the Manufacturer Importer's Identification Number (API-P);
 - f) duly stamped power of attorney from the head of the company if the arrangement is assigned to a third party;
 - g) statement letter stating that the Good is not to be traded to end Consumers;
 - h) copy of the identification of the head of the company; and
 - i) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
 - 2) Motor Vehicle Authorized Agent
 - a) application letter signed by the head of the company;

- b) list of Goods along with the HS number and designation and amount of Goods;
- c) copy of Trade Business License (SIUP) or Authorized Agent Acknowledgment Letter from the authorized technical institution;
- d) copy of the company's Taxpayer Registration Number (NPWP);
- e) copy of the Manufacturer Importer's Identification Number (API-P);
- f) copy of the Importer's Identification Number (API);
- g) copy of supplier appointment from manufacturer;
- h) copy of appointment as motor vehicle authorized agent from the authorized agent;
- i) statement letter stating that the Good is not to be traded to end Consumers;
- j) copy of the identification of the head of the company; and
- k) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
- 3) General importer as supplier
 - a) application letter signed by the head of the company;
 - b) list of Goods along with the HS number and designation and amount of Goods;
 - c) copy of Trade Business License (SIUP);
 - d) copy of the company's Taxpayer Registration Number (NPWP);
 - e) copy of the General Importer's Identification Number (API-U);
 - f) duly stamped power of attorney from the head of the company if arrangement is assigned to a third party;
 - g) copy of appointment or cooperation agreement between the manufacturer and the Importer as supplier;
 - h) copy of the identification of the head of the company; and
 - i) copy of the identification of the attorney-in-fact, if the arrangement is assigned to a third party.
- (3) The submission of the SPKPLBI application referred to in paragraph (1) may be done by direct submission or through a delivery service to the UPP Coordinator and Implementer of the Ministry of Trade of the Republic of Indonesia, Jalan M.I. Ridwan Rais Nomor 5, Jakarta Pusat 10110.
- (4) The application submission referred to in paragraph (1) is done by presenting the original document, if necessary.
- (5) UPP Coordinator and Implementer issue:
 - a. SPKPLBI within at the latest 2 (two) working days as of the receipt of the complete and satisfactory application; or

- b. rejection of SPKPLBI issuance within at the latest 2 (two) working days as of the receipt of application in the event that the application is incomplete and/or unsatisfactory.
- (6) The SPKPLBI is valid for 2 (two) years as of the issuance date and may be extended.
- (7) The format of the application to obtain SPKPLBI, SPKPLBI, and rejection to issue the SPKPLBI is as referred to in Appendix IX, Appendix X, and Appendix XI of this Minister Regulation.

Article 16

- (1) Businessmen who fail to meet the requirements referred to in Article 4 and/or Article 7 point a must recall the Goods from the market and are prohibited from trading the relevant Good.
- (2) The recall of Goods from the market is done upon the order of the Director General of Standardization and Consumer Protection on behalf of the Minister.
- (3) The cost of the recall of Goods from the market is borne by the Businessman.

Article 17

Goods that have been recalled by the Businessman as referred to in Article 16 may be re-traded if the provisions on Bahasa Indonesia Label affixing on Goods under this Minister Regulation have been met.

Article 18

- (1) Guidance and supervision of Bahasa Indonesia Label affixing on Goods as provided in this Minister Regulation are conducted by the Minister.
- (2) The Minister assigns the guidance and supervision authority referred to in paragraph (1) to the Director General of Standardization and Consumer Protection.
- (3) The implementation of guidance and supervision referred to in paragraph (2) may be conducted solely by the Director General of Standardization and Consumer Protection or jointly with the relevant technical institution in the central and/or regional government.
- (4) The guidance referred to in paragraph (1) is conducted in the form of service and information dissemination, education, and consultation, directly and indirectly to Businessmen and/or Consumers.
- (5) The supervision referred to in paragraph (1) is conducted in accordance with the laws and regulation concerning provisions and procedure of Goods and/or service supervision.

Businessmen that violate the provision referred to in Article 2 paragraph (1) or Article 7 point b will be sanctioned pursuant to the provision of Law Number 8 of 1999 concerning Consumer Protection.

Article 20

- (1) Businessmen referred to in Article 16, in the event of failure to recall goods from the market, will be penalized with an administrative sanction in the form of:
 - a. Revocation of SIUP and/or API by the SIUP/API issuing officer; or
 - b. Revocation of other business licenses by the authorized officer.
- (2) SIUP and/or API revocation referred to in paragraph (1) point a, if:
 - a. the goods recalled from the market is related to the safety, security, and health of the Consumer as well as the environment, the revocation will be done upon at the most 2 (two) written warnings within 12 (twelve) working days at the most; or
 - b. goods other than those referred to in point a, SIUP and/or API revocation is conducted upon 3 (three) written warnings with 7 (seven) working days in between.
- (3) In the event that the Businessman is penalized with administrative sanction as referred to in paragraph (1), the Director General of Standardization and Consumer Protection will send a business license revocation recommendation to the relevant institution/authorized officer.

Article 21

- (1) Businessmen producing or importing goods that are not stipulated in the Appendix to this Minister Regulation and have affixed Bahasa Indonesia label may keep the Bahasa Indonesia label affixed in accordance with the characteristics of the good.
- (2) Businessmen producing or importing goods that are not stipulated in the Appendix to this Minister Regulation and have not affixed Bahasa Indonesia label may affix Bahasa Indonesia label in accordance with the characteristics of the good.

Article 22

(1) Businessmen producing or importing goods as stipulated in Appendix I to Appendix V of this Minister Regulation that have been distributed in the domestic Market, upon the entry into effect of this Minister Regulation must adjust the bahasa Indonesia label affixing to the provisions of this Minister Regulation. (2) The label affixing adjustment referred to in paragraph (1) is conducted within at the latest 6 (six) months since this Minister Regulation enters into effect.

Article 23

Appendix I to Appendix XI are inseparable parts of this Minister Regulation.

Article 24

When this Minister Regulation enters into effect, the Regulation of the Minister of Trade Number 62/M-DAG/PER/12/2009 concerning Obligation to Affix Label on Goods as amended by the Regulation of the Minister of Trade Number 22/M-DAG/PER/5/2010, is revoked and is deemed invalid.

Article 25

This Minister Regulation enters into effect within 6 (six) months as off its permutation.

For public cognizance, this Minister Regulation shall be announced by publishing it in the State Gazette of the Republic of Indonesia.
