

# STRATEGIC PLAN OF ACTION ON ASEAN COOPERATION ON FISHERIES 2021-2025

**Final** 

**ASEAN SECTORAL WORKING GROUP ON FISHERIES** 

#### 1. Introduction

The Strategic Plan of Action for ASEAN Cooperation on Fisheries (SPA-Fisheries) was adopted by the 38<sup>th</sup> AMAF Meeting in 2016 to ensure that strategic thrusts and action programmes of the Vision and Strategic Plan of the ASEAN Cooperation in Food, Agriculture and Forestry (SP-FAF 2016-2025) relevant to the fisheries sector are implemented during the first five years covering 2016-2020. The SPA-Fisheries (2016-2020) contained 65 activities and sub-activities that are aligned with the 6 strategic thrusts and 19 action programmes of the SP-FAF 2016-2025. To assess the progress of implementation of the strategic plans of food, agriculture and forestry sector, the Special SOM-40<sup>th</sup> AMAF in 2019 requested all relevant Working Groups (WGs) in coordination with the ASEAN Secretariat to review their respective strategic plans and recommend appropriate activities for the SPA 2021-2025.

The ASEAN Sectoral Working Group on Fisheries (ASWGFi) has made good progress in the implementation of the SP-FAF 2016-2020. From the lists of 65 activities and sub-activities, 31% are completed, 43% are on-going implementation and 26% remain unimplemented. Some of the notable accomplishments include the adoption of several regional guidelines relating to traceability system for aquaculture products, catch documentation scheme, an early warning system for aquatic animal health emergencies and cold chain management for seafood. The issuance of the ASEAN-SEAFDEC Common Position on the Inclusion of Commercially-exploited Aquatic Species to CITES Appendix, including the Joint Declaration on Regional Cooperation for Combating IUU Fishing and Enhancing the Competitiveness of ASEAN Fish and Fishery Products were also accomplished. Some of the on-going activities are focusing on the conduct of ASEAN General Fisheries Policy feasibility study, developing guidelines and action plan to combat antimicrobials resistance (AMR) in aquaculture, pilottesting of electronic catch documentation scheme, establishing the Multilateral Arrangement for the Mutual Recognition of Agri-food Standards and Conformity Assessment, and establishing the ASEAN Network for Combating Illegal, Unreported and Unregulated (IUU) Fishing. Despite these achievements, limited progress has been noted in the implementation of activities relating on harmonising accreditation, inspection and certification processes, fishery product standard development, harmonising SPS measures on aquatic animal quarantine and health certification, and climate change hazard risk assessment.

ASWGFi acknowledges the lingering COVID-19 pandemic has caused serious impacts on our lives and economy, including our fisheries activities and industries. To ensure programme continuity and further support the implementation of the Vision and SP-FAF (2016-2025), the SPA-Fisheries 2021-2025 was developed taking into account the on-going and unimplemented activities and sub-activities from the previous SPA. It also takes into account recent developments in the ASEAN fisheries sector (e.g. ASEAN Chairmanship priorities and establishment of the Expert Working Group on ASEAN Good Aquaculture Practices).

#### 2. ASEAN Cooperation on Fisheries

The fisheries sector is vital to food and nutritional security, economy and livelihood of the people in the ASEAN region. It accounts for 18% of the global fisheries production and 40% of the animal protein supplies of the population. It is also an important source of export earnings valued at US\$ 1.95 billion in 2018 and a source of income and livelihood for more than 10 million people directly engaged in fishing and aquaculture.

The fisheries sector is one of the priority sectors for ASEAN economic integration. Most of the region's fish stocks are heavily exploited, while marine ecosystems such as, mangroves, and sea-grasses, and coral reefs are severely degraded. The problem of Illegal, Unreported and Unregulated (IUU) fishing and the plethora of effects of climate change further exacerbate the problem of overfishing and overstressed aquatic ecosystems. Moreover, the stringent trade measures and emerging concerns (e.g. traceability, forced labor, and human trafficking issues) pose a serious threat to the competitiveness of fish and fishery products in the region. While aquaculture is often seen as a key compensation measure where impacts on fisheries are unavoidable, it is often constrained by several factors relating to water availability, water pollution, and over-intensive farming practices. Promoting the long-term sustainable development of Southeast Asia's fishery resources would require not only effective national policies in place but also regional cooperative approaches considering the common-pool nature of fisheries resources.

Under the Cooperation in Food, Agriculture and Forestry in ASEAN, the ASEAN Sectoral Working Group on Fisheries (ASWGFi) was established to oversee the development and implementation of the relevant programme and activities in the fisheries sector with the support from the following sub-working groups: i) ASEAN Fisheries Consultative Forum (AFCF); ii) ASEAN Shrimp Alliance (ASA); iii) Fisheries Consultative Group of the ASEAN-SEAFDEC Strategic Partnership (FCG/ASSP); and iv) the Expert Working Group on ASEAN Good Aquaculture Practices (EWG-GAqP).

# 3. Strategic Plan of Action for ASEAN Cooperation on Fisheries, 2021-2025

The goal of the SPA-Fisheries 2021-2025 is to ensure a competitive, inclusive, resilient and sustainable fisheries sector contributing towards economic growth, poverty alleviation, food security and nutrition in the ASEAN region.

Building on the progress achieved by the previous strategic plan, the SPA-Fisheries 2021-2025 continues the strategic thrusts and action programmes of the Vision and Strategic Plan of ASEAN Cooperation in Food, Agriculture and Forestry 2016-2025 that remain relevant to the fisheries sector. It includes activities that were initiated from the previous SPA- Fisheries 2016-2020 but not completed, those previously planned but not yet implemented, and new activities that take into account recent developments of the fisheries sector in the region. The strategic thrusts and its corresponding action programmes and activities are provided in **Annex 1**.

#### 4. Implementation Arrangement

The ASEAN Sectoral Working Group on Fisheries (ASWGFi) will implement the relevant activities of the SPA-Fisheries (2021-2025), with the support from its technical sub-working groups. Country Lead may be assigned to steer and initiate the implementation of a particular activity or priority deliverable, in coordination with the ASEAN Secretariat. Priority activities may be funded by AMS and/or through collaboration with Dialogue Partners and International and Regional Organisations. The progress of the implementation activities and priority deliverables will be reported in the annual meetings of ASWGFi and SOM-AMAF, while a final review will be conducted in 2025.
