

**ASEAN AGREEMENT ON
THE MOVEMENT OF NATURAL PERSONS**

ANNEX 1

**SCHEDULE OF COMMITMENTS FOR THE TEMPORARY ENTRY OR
TEMPORARY STAY OF NATURAL PERSONS**

MALAYSIA

1. This Schedule sets out the commitments of Malaysia and the general conditions and limitations governing those commitments in accordance with Article 6 (Schedules of Commitments for the Temporary Entry and Temporary Stay of Natural Persons) of the MNP Agreement in relation to the temporary entry and temporary stay of a natural person of another Member State, which apply only in relation to the categories of natural persons set out in this Schedule.
2. A natural person of a Member State shall be granted temporary entry or temporary stay in Malaysia in accordance with paragraph 1 of Article 4 (Grant of Temporary Entry or Temporary Stay) of the MNP Agreement.
3. For greater certainty, in accordance with paragraph 3 of Article 4 (Grant of Temporary Entry or Temporary Stay) of the MNP Agreement, Malaysia may deny temporary entry or temporary stay to natural persons of another Member State who do not comply with paragraphs 1(a) and 1(b) of Article 4 (Grant of Temporary Entry or Temporary Stay) of the MNP Agreement.
4. References to Central Product Classification (CPC) in this Schedule refer to the CPC codes as used in the Provisional Central Product Classification (Statistical Papers Series M No.77, Department of International Economic and Social Affairs, Statistical Office of the United Nations, New York, 1991).
5. The use of (**) against individual CPC codes indicates that the specific commitments for that code shall not extend to total range of services covered under that code.
6. Section I refers to horizontal commitments and Section II refers to sector specific commitments. An empty (blank) conditions and limitations in Section II means that the general conditions and limitations of the horizontal section, including the length of stay, shall apply and could be read as “unbound, except as indicated in Section I”.
7. The Schedules of other Member States shall not be used to interpret Malaysia’s commitments or obligations under the MNP Agreement.

Additional Notes for Malaysia

8. For greater certainty, Malaysia’s commitment in respect of the supply of financial services by a financial institution of a Member State through the presence of natural persons of a Member State in the territory of Malaysia is as stipulated in Section II.E (Specific Commitments in Financial Services) of this Schedule.

In respect of offshore banks, offshore investment banks, commercial banks, international Islamic banks, investment banks, Qualified ASEAN Banks (QABs), offshore direct insurance companies, offshore reinsurance companies, offshore insurance brokers, offshore insurance underwriting managers, offshore insurance managers, direct insurance companies, reinsurance companies, international takaful operators and representative offices of commercial banks and investment banks, the following general conditions and limitations in Financial Services Horizontal Commitments shall apply in addition to specific general conditions and limitations as specified for each Financial Service Activity.
3. For further clarity,
 - a. Malaysia's commitments cannot be interpreted as applying to the supply of Shariah-compliant financial services, unless specific entries are made in the banking, insurance or capital markets sub-sectors accordingly. This approach is consistent with Malaysia's commitments under the WTO and other existing free trade agreements;
 - b. only where commitments are made under the ASEAN Banking Integration Framework, a distinction is made between QABs and non-QABs. All other commitments apply to all ASEAN members.
4. For greater certainty, temporary entry of natural persons in respect of supply of service shall be through the mode of commercial presence of offshore banks, offshore investment banks, commercial banks, international Islamic banks, investment banks, QABs, offshore direct insurance companies, offshore reinsurance companies, offshore insurance brokers, offshore insurance underwriting managers, offshore insurance managers, direct insurance companies, reinsurance companies, international takaful operators and representative offices of commercial banks and investment banks, consistent with Malaysia's commitments in relation to Article 13 (Market Access for Financial Institutions) of the Annex on Financial Services under the ASEAN Trade in Services Agreement dated 7 October 2020¹.

¹ Malaysia's commitments under the said Article are subject to the transitional provisions under Article 36 (Transitional Arrangement Relating to the AFAS) of the ASEAN Trade in Services Agreement including the duration which the ASEAN Framework Agreement in Services and, more specifically, Malaysia's Schedule of Specific Commitments of Financial Services under AFAS, will remain in force.

5. For greater certainty, in the event of any inconsistency between the commitments in this Schedule and Malaysia's Ninth Package of Commitments on Financial Services under the ASEAN Framework Agreement on Services, the commitments in this Schedule shall prevail.
