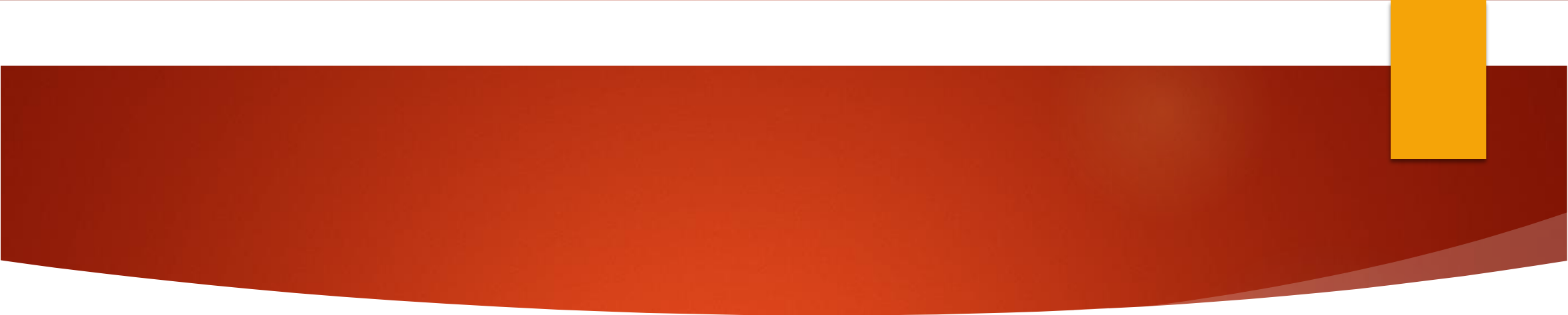

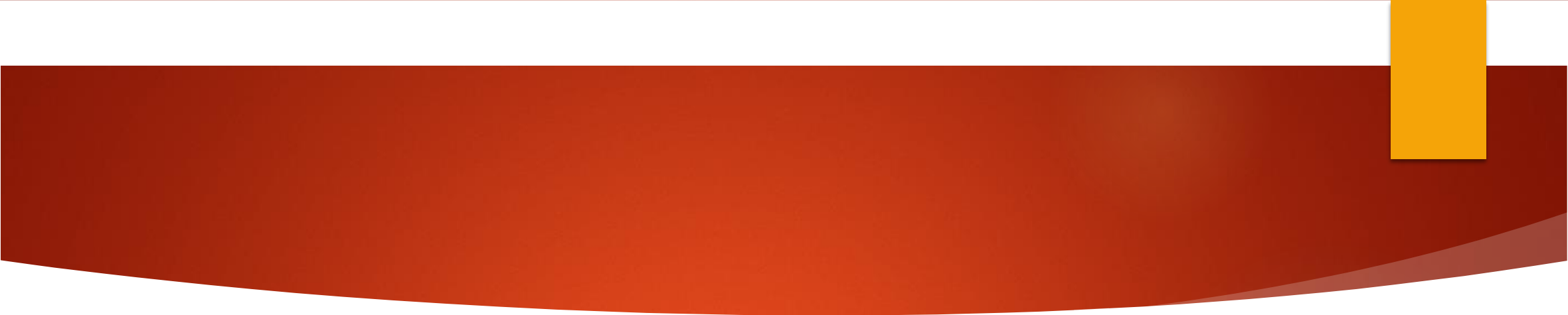

Invitation by AMS (through WGSMD National Focal Points) for companies to participate in the 2026 AMA: - Issuance of invitation by Malaysia: 12 June - Circulation by AMS WGSMD FP to Companies: before 25 June ➤ Meanwhile AMS is suggested to inform companies / industries that the 2026 AMA will commence soon ➤ Meanwhile ASEC to prepare and upload the promotion material			Ongoing

6.	Evaluation of Companies Submission: - BOJ Chair to distribute (via email) to AMS BOJ Members the compiled company submission: by 7 Aug - Each AMS BOJ Member to conduct evaluation: 10 – 19 Aug - AMS BOJ Members to submit to BOJ Chair their evaluation results: by 21 Aug							
7.	Convene the 2nd BOJ Meeting (online): 24 Aug (for each AMS to provide update on their submission)							
8.	BOJ Chair to tabulate, validate and certify the Overall Tally Sheets (OTS): by 4 Sep ➤ BOJ Chair may call for an online coordination with the AMA Co-lead (Brunei and Philippines) and ASEC prior to the announcement							
9.	Convene the 3rd BOJ Meeting (online): 9 Sep (morning), tbc ➤ Announcement of Short-Listed Companies: BOJ Chair to inform the Members on the Shortlisted Companies, may involve discussions and consensus.

10.	Issuance of invitation by Malaysia to the shortlisted companies, through AMS BOJ Members: by 15 Sep ➤ 3 companies from each categories. The invitation is for the companies to make presentations at the 4th BOJ Meeting under Item 12.							
11	Online ASOMM 28 Sep – 2 Oct (tbc) ➤ BOJ Chair to present/provide update on the AMA preparations, incl. the short-listed companies							
12	Convene 4th BOJ Meeting: 7 Oct ➤ For the shortlisted companies to present their projects and for BOJ Members to select the winners							
13	In-person AMMin-AMVest: Oct 2026, Kuala Lumpur, Malaysia ➤ Announcement of <u>Winners</u>: BOJ Chair to report to ASOMM the BOJ's decision on the Winners; and then the ASOMM Chair to report the ASOMM's endorsement on the Winners to the AMMin ➤ Awarding Ceremony during the AMMin-AMVest Gala Dinner
