

**ASEAN-France Development Partnership:
Practical Cooperation Areas (2022-2027)**

These Practical Cooperation Areas set out priority areas for engagement and is aimed at implementing the shared commitments for an enhanced, deeper, and mutually beneficial ASEAN–France Development Partnership for the period 2022-2027 to further substantiate the cooperation with a focus to foster resilient, inclusive and sustainable growth models in the region, in practical areas where ASEAN and France have expertise and mutual interests, including fight against climate change, biodiversity, global health and education.

Explore cooperation in the area of peace and reconciliation, including with the ASEAN Institute for Peace and Reconciliation (ASEAN-IPR), in accordance with its Terms of Reference, as well as support for the activities by the experts listed in the ASEAN Women for Peace Registry (AWPR) as agreed by ASEAN-IPR.
