

**ASEAN-Switzerland Sectoral Dialogue Partnership:
Practical Cooperation Areas (2022-2027)**

These Practical Cooperation Areas (PCA) set out priority areas for ASEAN-Switzerland engagement and are aimed at implementing the shared commitments for an enhanced, deeper, and mutually beneficial ASEAN-Switzerland Sectoral Dialogue Partnership to further substantiate the cooperation with a focus on practical areas where ASEAN and Switzerland have expertise and mutual interest:

Peace and Reconciliation		
1.	Continue cooperation in the area of peace and reconciliation, including with the ASEAN Institute for Peace and Reconciliation (ASEAN-IPR), in accordance with its Terms of Reference, as well as explore support of activities by the experts listed in the ASEAN Women for Peace Registry (AWPR) as agreed by ASEAN-IPR.	Immediate and medium term
2.	Explore cooperation to advance the Women, Peace and Security agenda by increasing women's equal, full, meaningful, and effective participation in all stages of peace processes in the ASEAN region through concrete activities and exchanges, expanding existing networks and collaboration in building capacity for women mediators or facilitators.
