

Practical Cooperation Areas for ASEAN-Chile Development Partnership 2021-2025

ASEAN-Chile Practical Cooperation Areas aim to implement future cooperation under the framework of the ASEAN-Chile Development Partnership to further substantiate the Partnership and cooperation with a focus on practical areas for mutual benefits, where ASEAN and Chile have expertise and mutual interest. These Practical Cooperation Areas (PCA) will also contribute to the realisation of ASEAN Community Vision 2025 goals as well as further strengthen ASEAN-Chile relations.

ASEAN and Chile hereby agree that the following areas will be given priority for the cooperation between both sides. Programmes, projects and/or cooperative activities will be developed to undertake practical cooperation under these areas:

1. Political-Security Cooperation

- 1.2. Human Rights, Good Governance and Combating Corruption

2. Economic Cooperation

- 2.1. Trade and Investment
- 2.2. Micro, Small and Medium Enterprises (MSMEs)
- 2.3. Digital Economy

- 2.5. Food, Agriculture and Forestry
- 2.6. Marine Resources including Fisheries
- 2.7. Mineral cooperation
- 2.8. Science, Technology and Innovation
- 2.9. Sustainable and renewable energy including energy efficiency

- 2.11. Transport

3. Socio-cultural Cooperation

- 3.1. Education and Youth Development
- 3.2. Environment and Climate Change
- 3.3. Disaster Management and Disaster Risk Reduction (DRR)
- 3.4. Human Resources Development
- 3.5. People-to-People Contact, Sports, Culture and Arts
- 3.6. Health Cooperation, including public health emergencies
