## **Viet Nam**

### **I. Criminal procedures:**

1. Police offices at central, provincial, district levels.
2. Public Prosecution Institutions at various levels (supreme, provincial, district levels).
3. Courts at various levels (supreme, provincial, district courts).

### **II. Civil procedures:**

1. The Supreme People's Court, provincial, district courts.
2. Public Prosecution Institutions (if necessary).

### **III. Administrative procedures:**

1. People's Committees of provinces and districts.
2. Inspectors specialising in Industrial Property and Copyrights (belonging to Ministry of Science,

Technology and Environment, Departments of Science, Technology and Environment of provinces; and Ministry of Culture and Information, Departments of Culture and Information of provinces, respectively).

3. Police offices.
4. Customs offices.
5. Market control organisation (in the coming time called “trade inspectors”).
