



REGULATION OF THE MINISTER OF AGRICULTURE

NUMBER 86/Permentan/OT.140/8/2013

CONCERNING

IMPORT RECOMMENDATION OF HORTICULTURE PRODUCTS

BY THE GRACE OF GOD ALMIGHT

THE MINISTER OF AGRICULTURE,

Considering :

- a. that in the context of importation of horticulture products, has been stipulated Regulation of the Minister of Agriculture Number 47/Permentan/OT.140/4/2013 concerning Import Recommendation of Horticulture Products;
- b. that in order to simplify the import process of horticulture products, and providing certainty in servicing Import Recommendation of Horticulture Products, necessitate the review of Regulation of the Minister of Agriculture Number 47/Permentan/OT.140/4/2013;

In view of :

4. Law Number 13 Year 2010 concerning Horticulture (State Gazette Year 2010 Number 132, Addendum Number 5170);
5. Law Number 18 Year 2012 concerning Food (State Gazette Year 2012 Number 227, Addendum Number 5360);
6. Government Regulation Number 38 Year 2007 concerning Division of Government Affairs between the Government, Provincial Regional Government and Regency/City Regional Government (State Gazette of the Republic of Indonesia Year 2007 Number 82, Addendum Number 4737);

Regulation of the Minister of Agriculture Number 90/Permentan/OT.140/12/2011 concerning Plant Quarantine Requirements and Measures for the Importation of Life Plant Produce in the Form of Fresh Bulbs into the Territory of the Republic of Indonesia, related with Regulation of the Minister of Trade Number 16/Permentan/OT.140/3/2012;

13. Regulation of the Minister of Agriculture Number 88/Permentan/PP.340/12/2011 concerning Food Safety Control of Importation and Exportation of Fresh Food of Plant Origin; and
14. Regulation of the Minister of Agriculture Number 94/Permentan/OT.140/12/2011 concerning Entry and Exit Points of Carrier Media of Quarantine Animal Disease and Quarantine Plant Disturbing Organism;

Observing : Result of Economic Limited Coordination Meeting on 27 August 2013 related to Trading System Policy of Beef, Horticulture and Others (letter Number S-169/M.EKON/08/2013 on 27 August 2013);

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF AGRICULTURE CONCERNING IMPORT RECOMMENDATION OF HORTICULTURE PRODUCTS.

## CHAPTER I GENERAL PROVISIONS

### Article 1

In this Regulation what is referred to as:

1. Horticulture Product Import is a series of activities of entering horticulture products from overseas into the Customs area of the Republic of Indonesia.
2. Entry Point is sea ports and airports that have been specified by the Minister as a place of entry.
3. Horticulture Product is all produce originating from horticulture plant that are fresh or processed.
4. Import Recommendation of Horticulture Products hereinafter referred to as RIPH is as letter issued by the Minister of Agriculture or appointed official and is a requirement for the issuance of Import Approval.
5. Horticulture Business is all activities to produce and/or provide services related to horticulture.
6. Importer Producer of Horticulture Product, hereinafter referred to as IP-Horticulture Product is a manufacturing company which uses Horticulture Product as raw

materials or supporting materials in the production process and not traded or transferred to other parties.

7. Registered Importer of Horticulture Product, hereinafter referred to as RI-Horticulture Product is a company which imports Horticulture Product for business purposes by trading and/or transferring it to other parties.
8. Director General is the Director General of Processing and Marketing of Agricultural Products, Ministry of Agriculture.

#### Article 2

This Regulation is intended to be the legal basis for issuing RIPH as a requirement for the issuance of import approval.

#### Article 3

This Regulation is intended to:

- a. increase the effectiveness and efficiency of horticulture product import management;  
and
- b. provide certainty in RIPH issuing service.

### CHAPTER II REQUIREMENTS AND PROCEDURES OF ISSUING AND RECOMMENDING IMPORT OF HORTICULTURE PRODUCTS

#### Part One

#### General

#### Article 4

- (1) Import of Horticulture Product can be conducted by importer after obtaining import approval by the Minister of Trade or appointed official.
- (2) Import approval as intended in paragraph (1) is issued after obtaining RIPH from the Minister of Agriculture.

#### Article 5

- (1) Import of Horticulture Product can be conducted prior to harvest season, during harvest season and after harvest season within a certain time period.

- (2) Within a certain time period as intended in paragraph (1) is stipulated by the Minister of Agriculture and submitted to the Minister of Trade.
- (3) Import period of horticulture products as intended in paragraph (1) is not applicable to horticulture product of fresh chili and shallot for consumption.
- (4) Issuance of RIPH of fresh horticulture products for consumption in the form of chili and shallot is based on determined reference price from the Minister of Trade.

#### Article 6

- (1) Issuance of RIPH as intended in Article 4 paragraph (2) is authorized to the Director General on behalf of the Minister of Agriculture.
- (2) RIPH as intended in paragraph (1) is issued in the form of letter according to format-1, format-2, format-3 and/or format-4 as included in Attachment I which is an integral part of this Regulation.
- (3) RIPH includes;
  - a. RIPH number;
  - b. company name and address;
  - c. company Director name and address;
  - d. number and date of application letter;
  - e. product name;
  - f. tariff post/HS of Horticulture Product;
  - g. country of origin;
  - h. manufacturing location (for industrial material); and
  - i. entry point.
- (4) RIPH as intended in paragraph (2) is an Attachment that is an integral part of this Import Approval Letter.

#### Article 7

- (1) Horticulture product that be assigned RIPH includes fresh horticulture products for consumption, fresh from industrial raw materials, processed for industrial raw materials, and processed for consumption as stated in Attachment II which is an integral part of this Regulation.
- (2) Horticulture Product as intended in paragraph (1) for consumption must meet food safety requirements which are regulated by its own Regulation.

## Part Two

### Issuing Requirements for Import Recommendation of Horticulture Products

#### Article 8

- (1) RIPH is issued with the following administrative requirements:
  - a. Fresh horticulture products for consumption shall include:
    - Photo copy of RI-Horticulture Product from the Ministry of Trade;
    - Photo copy of General Importer Identification Number (API-U); and
    - Statement of not importing horticulture products which exceed 6 (six) months after the harvest period.
  - b. Fresh and processed horticulture products for industrial raw materials shall include:
    - Technical letter of consideration, industry location, and industrial capacity from the Minister of Industry;
    - Photo copy of Importer Producer Identification Number (API-P).
  - c. Processed horticulture product for consumption shall include:
    - Photo copy of RI-Horticulture Product from the Ministry of Trade;
    - Importation approval letter from the Agency of Drug and Food Control; and
    - Photo copy of General Importer Identification Number (API-U).
- (2) Issuance of RIPH for fresh produce for consumption, in addition to meeting the administrative requirements as intended in paragraph (1) item a must be accompanied with the following technical requirements:
  - a. plantation/business area registration information or Certificate of Good Agriculture Practices/GAP;
  - b. post harvest packing house registration issued by authorized agency from the country of origin;
  - c. statement of ownership of storage and distribution facilities for horticulture products according to their characteristics and product type;
  - d. statement of suitability of storage capacity; and
  - e. information of distribution plan according to the time and area (regency/city).
- (3) Technical requirements as intended in paragraph (2) item a and b is translated into Bahasa Indonesia.

## Part Three

### Issuing Procedures for Import Recommendation of Horticulture Products

#### Article 9

- (1) Issuance of RIPH is conducted based on the application by the applicant.
- (2) Application as intended in paragraph (1) is accompanied with information of:
  - a. product name;
  - b. tariff post/HS of Horticulture Product;
  - c. time of entry;
  - d. country of origin; and
  - e. point of entry.

#### Article 10

- (1) Application to obtain RIPH can only be served by online electronic system through the specified web portal.
- (2) Web portal as intended in paragraph (1) is a web based application system developed to serve the issuance of RIPH.

#### Article 11

- (1) In case of force majeure which causes the online system to not operate, submission of RIPH application can be conducted manually at the latest by the end of RIPH service date.
- (2) Force majeure as intended in paragraph (1) is determined by information letter from the authorized agency.

#### Article 12

- (1) The Director General after receiving the application as intended in Article 9 paragraph (1) in a maximum time period of 7 (seven) working days has finished checking the completeness of the RIPH requirements as intended in Article 8.
- (2) If the document inspection result is declared complete, RIPH can be issued.
- (3) If the document inspection result is declared incomplete, the document is returned.

### Article 13

- (1) In one year, RIPH is issued 2 (two) times which is valid for a period from January to June and from July to December.
- (2) RIPH service as intended in paragraph (1) for the period from January to June, the submission of application is open for 15 working days from the start of November of the previous year, and for the period from July to December, the submission of application is open for 15 working days from the start of May of the current year.
- (3) RIPH of fresh horticulture products for industrial raw materials, processed for industrial raw materials, and processed for consumption is issued 1 (one) time within 1 (one) period for 1 (one) company.
- (4) RIPH service as intended in paragraph (1) is not applicable for fresh horticulture product in the form of chili and shallot as intended in Article 5 paragraph (3) and paragraph (4).

### Article 14

In case where the administrative requirement document or technical requirement document as intended in Article 8 is incorrect, shall be liable to sanction by not granting RIPH for a period of one year.

## CHAPTER III TRANSITIONAL PROVISION

### Article 15

RIPH that has been issued and still valid prior to the legislation of this regulation, is declared valid.

## CHAPTER IV CLOSING PROVISIONS

### Article 16

With the enactment of this Regulation, Regulation of the Minister of Agriculture Number 47/Permentan/OT.140/4/2013 is revoked and declared invalid.



Article 17

This Ministerial Regulation shall come into effect on the date of its legislation.

For public cognizance, ordering the promulgation of this Ministerial Regulation by including it in the State Gazette of the Republic of Indonesia.
